Categories of Personal Data Processed

Visual data (CCTV camera footage) is processed through security cameras located in and around our company buildings and facilities by fully automated means. These data constitute personal data relating to an identified or identifiable natural person. No audio recording is performed.

Method of Personal Data Collection

Your personal data is collected fully automatically through security cameras installed inside and outside the building.

Purposes of Processing Personal Data

Your personal data is processed in accordance with the general principles set forth in Article 4 of KVKK for the following purposes:

- *Ensuring Physical Premises Security: Ensuring the security of buildings, facilities, corridors, parking areas and other common areas; monitoring visitor entry and exit; preventing and deterring criminal acts such as theft, sabotage and terrorist incidents.*

- *Fulfilment of Legal Obligations: Compliance with obligations arising from applicable legislation (such as the Regulation on Occupational Health and Safety Measures in Workplace Buildings and Annexes and other relevant laws).*
- *Resolution of Legal Disputes and Protection of Rights: Use as evidence in potential legal disputes, conducting legal proceedings, and establishment, exercise and protection of rights.*
- *Protection of Legitimate Interests: Protection of HASEKI's legitimate interests, such as incident detection, investigation, evidence creation, and increasing operational efficiency and security.*

Legal Grounds for Processing Personal Data

Your personal data is processed based on the following legal grounds set out in Article 5 of KVKK and Articles 6 and 9 of GDPR:

- *Processing is mandatory for the data controller to fulfil its legal obligations.*
- *Processing is mandatory for the establishment, exercise or protection of a right.*
- *Processing is mandatory for the legitimate interests of the data controller, provided that it does not harm the fundamental rights and freedoms of the data subject.*

Recipients and Purposes of Data Transfer

Your personal data may be transferred, in line with the purposes stated above and within the framework of Articles 8 and 9 of KVKK and relevant GDPR provisions, to the following recipient groups:

- *Authorised Public Institutions and Organisations: Courts, public prosecutors, law enforcement authorities, enforcement offices and other competent authorities authorized by law.*
- *Business Partners and Service Providers: Security service providers, law firms and consultancy companies providing auditing and advisory services.*

Rights of the Data Subject

Pursuant to Article 11 of KVKK and Articles 15–22 of GDPR, data subjects have the right to:

- *Learn whether their personal data is processed*
- *Request information if personal data has been processed*
- *Learn the purpose of processing and whether data is used in accordance with its purpose*

- *Request correction or deletion*
- *Object to processing*
- *Request compensation for damages*
