I hereby accept and declare that my personal data may be processed in accordance with the general principles stated in Article 4 of the Personal Data Protection Law No. 6698 ("KVK Law"), including the principle of retention for the period stipulated in the legislation or necessary for the purpose for which they are processed; may be obtained, recorded, stored securely in physical or electronic media for a period of time appropriate for the purpose of processing, stored, maintained, modified, reorganized, disclosed and transferred in accordance with the legislation, taken over, classified, processed or the use of data may be prevented; I accept and declare that I have been informed by the Company regarding the above-mentioned issues and that I have explicit consent within the framework of the KVK Law.**
