

COMMERCIAL ELECTRONIC COMMUNICATION DISCLOSURE NOTICE

1. Who is the Data Controller?

This disclosure notice has been prepared by Haseki Turizm Saęlık İnş. San. ve Dış Tic. Ltd. Şti. (“Hürrem Sultan Hammam”), acting as the data controller, in accordance with the Turkish Personal Data Protection Law No. 6698 (“KVKK”), the General Data Protection Regulation (“GDPR”), and the Communiqué on the Principles and Procedures to be Followed in Fulfilling the Obligation to Inform, for the purpose of informing you regarding the sending of commercial electronic communications.

2. For What Purposes and Legal Grounds Do We Process Your Personal Data?

The identity information (name, surname) and contact information (telephone number, e-mail address) you share with us will be processed for the purpose of sending commercial electronic communications regarding advertisements, campaigns, promotions, and opportunities, provided that your explicit consent has been obtained pursuant to Article 5/1 of the Personal Data Protection Law No. 6698 (“Law”) and Article 6 of the GDPR.

The identity information (name, surname) and contact information (telephone number, e-mail address) you share with us may also be processed pursuant to Article 5/2(ç) of the Law for the purpose of fulfilling our legal obligations in cases where authorized institutions or organizations request information from our company or where we are required to notify such institutions (for example, fulfilling our notification obligations under the Regulation on Commercial Communication and Commercial Electronic Messages).

3. To Whom and For What Purposes Do We Transfer Your Personal Data?

The identity information (name, surname) and contact information (telephone number, e-mail address) you share with us may be shared with authorized institutions and organizations in legal disputes, with administrative authorities upon request in line with our legal obligations, and with service provider platforms from which we receive services in relation to the sending of commercial communications.

In addition, your consent records regarding commercial electronic communications may be shared with authorized institutions and organizations in order to fulfill our legal obligations.

4. Right to Withdraw Consent for Commercial Communications

If you do not wish to receive commercial communications, you may withdraw your consent at any time through the communication channels published on our website.

Once you withdraw your consent, no further commercial communications will be sent to you.

5. What Are the Methods of Collecting Your Personal Data?

Your personal data is collected through automatic and semi-automatic methods via forms completed electronically, SMS correspondence, and e-mail communications.

6. What Are Your Rights Regarding the Processing of Your Personal Data and How Can You Exercise These Rights?

Article 20 of the Constitution stipulates that everyone has the right to be informed about personal data concerning themselves. Article 11 of the KVKK lists the rights of personal data subjects under the law.

You may submit your requests within the scope of Article 11 of the KVKK, which regulates the rights of data subjects, to Haseki Turizm Saęlık İnş. San. ve Dış Tic. Ltd. Şti. through the “Application Form to the Data Controller” prepared for your convenience in accordance with the Communiqué on the Principles and Procedures for Applications to the Data Controller, available at:
